## Nomination by Petition

### **Section 5. Election of Officers and Directors.**

**Section 5b:** ... any eligible member may put forth their name to serve on the Board of Directors if they meet the qualifications. Eligibility shall consist of: President Elect 2 of 3 years service on the Board of Directors. Secretary-Treasurer at least 1 full year of Board Service. Directors shall have participated at the Committee level for 2 years.

**Section 5c:** Additional candidates for vacancies to be filled may be placed in nomination by signatures of at least 10 individuals of the REALTOR® members eligible to vote. The petition shall be filed with the Association Executive at least (3) weeks before the election.
